

**CVNA Minutes Oct. 5, 2016 7:00-8:30 PM Riverdale High School  
Minutes are posted on Collins View Nextdoor and on collinsview.org**

**SW Trails** Don Baack of SW Trails presented an opportunity for Collins View Neighborhood to join the process of improving our South West pedestrian infrastructure. South West In Motion (SWIM) was started in 1995 to facilitate connectivity in South West neighborhoods. SWIM is soliciting neighborhood nomination of future trails to get funds from a grant from the Bureau of Transportation. The purpose of this project is to close the gaps in pedestrian connectivity (like gaps in sidewalks to schools). Don brought a Collins View map on which we were to identify pedestrian connections on unbuilt roads and nominate them for the city's project. John Miller took the map. We need a point person to work with the SW trails group on this project. New neighborhood greenways might be on urban trails. We don't know what city is going to ask for. Not a lot of money is necessary for a trail, but the permit process is time consuming. Adjacent property owners will have a waiver of responsibility. Non profits want to work with SWIM to make it happen. We will have open houses. This is a years'+ long process. John Miller made a motion that we participate in this SW Trails project. Gene Lynard seconded. The motion passed by unanimous vote. At the November meeting we will nominate a representative and put it on Nextdoor.

**15 min.: City of Portland Environmental Services: Ashley Tjaden**

*[Ashley.Tjaden@portlandoregon.gov or 503-823-5281]* gave out great maps and printed information about the project. She detailed the anticipated time line and update for the [SW Terwilliger Sewer Construction Project](#) that starts this fall (or maybe January 2017). The work will close Terwilliger Blvd. from SW Castleridge Lane to Hwy 43. The project has been put on hold for two years because of the Sellwood Bridge construction.

- Sign up for email updates (by October 10) at the website. You can send an email to cell phone and it becomes a text message regarding unexpected updating of closures etc.

The Number 1 question is: "Why does street have to be closed?"

- Answers: (1) To move traffic through the work area in a single lane, flaggers would need to work 24 hours a day, which is cost prohibitive.
- (2) There would be no safe spot for vehicles to turn around if traffic backs up
- (3) The narrow road and curves obscure line of sight. Traffic lane restrictions would put workers and the public in danger, especially at night."

- All equipment will be staged right on the road so no other streets need to be closed.
- The 8” diameter sewer pipe will be down under Terwilliger Blvd. Putting a sewer line underneath private property is not a best practices. The new sewer will only serve the houses right adjacent to it, replacing one that is old and deteriorating.

Several local governments are involved because of its location. Environmental Services is working with the city and sheriff to enforce traffic behavior. The recommended detour is HWY 43 up to Taylors Ferry.

- There will be a sign right at the Lewis and Clark Law School circle to turn around.
- Adequate signage. Let Ashley know if remedial signage is needed. James Luce recommended a sign at the Taylors Ferry/ Terwilliger intersection.

The work accommodates Tryon Creek’s environmental protected area, as well as the public’s access to the State Park’s trails, bike paths and activities.

**Riverdale High School**, Judy Taylor was reporting for Paula, who was at a conference. Parent teacher conferences are scheduled for Thursday and Friday (Oct 6-7). PSAT and SAT are this month.

### **Old Business Review**

**ORCMP** - Off Road Cycling Master Plan advisory committee meeting

Advisory Committee's completion date has been pushed off 3-4 months into 2017.

- At the September meeting, I observed a fairly sane examination of sites around the city. Next meeting is scheduled before Holidays in November.
- Community Outreach will be in JAN FEB MAR, 2017.
- Forest Park will be the subject of a separate meeting, sometime.
- RVNA is on the Jumbo List, yet to be pared down by staff via administrative procedures.

**METRO BOND MEASURE 26-178:** A political organization has been formed to support the bond measure, protectournaturalareas.com. An endorsement from NWTa (Northwest Trails Alliance) was posted on the organization's Facebook page that NWTa was excited the measure would "support programming for Mountain Biking." I checked, and there is no such language in the Metro legislation. Several of us will be challenging this - outside of CVNA, of course.

**FoRVNA** - Friends of River View Natural Area: Good News - FoRVNA has received a draft of the Stewardship Agreement for RVNA. Maryellen, Fran, and I met with PP&R on 9/23/16 to discuss the draft. We have returned it with our comments. PP&R hopes to have the agreement signed in October. We will report on the agreement in November.

**Land Use**, Dave and Dixie Johnston: Pre Application Conference Re 1105 SW Maplecrest Dr. (R-20, .89 acres): is scheduled for Oct 12 at 1PM. The developer wants to get two pieces out of it. The Pre app conference is an opportunity for the developer to meet with city staff and see what the rules are and what they allow. It is not a time for people to testify and give opinions. A “For Sale” sign is on the property. City Planner will give Dave a copy of the city’s report about requirements. Dave will have it for CVNA’s Nov. meeting.

- Lowell Patten property on Boones Ferry. Nothing going on.(paper-wise) They have not submitted anything. They have until Nov 7 when their pre application expires. James Luce sees trucks with brush clearing cat machines on the property.
- 708 Maplecrest Ct. has a permit authorizing new construction for an additional house behind the original house, and is ready for them to get the building permit.

**NET**, Bob Fischer: The Collins View NET team and the South Burlingame NET team will conduct “Operation Bull Run” (a post-earthquake search and rescue hands-on exercise) on Oct 22 at the Police Department’s Scenario Village. 16-20 Volunteers from our community are needed to act as injured people (“moulaged” Hollywood-style trauma make up) and to populate the street scene.
